Dear Exhibitor,

For your smooth and successful participation and thus, for the success of the exhibition we summarize the key rules and information governed in detail by the Rules of Procedure and the General Terms and Conditions of the exhibition which are available at the website szantofoldinapok.hu.

1. Participation in the exhibition is subject to the submission of the registration form by the deadline and the payment of the total gross fee for the area indicated on it as an advance. A minimum requirement during the filling in of the registration form is to accurately enter the applicant's data and the area requested, and to properly sign the registration form.
2. By returning the copy of the registration form properly signed by the Exhibitor electronically to the Main Organizers at ags@megfosz.com and szantofoldinapok@nak.hu the contract and order will take effect. Exhibitor thus acknowledges that he has got to know and accepted the provisions of the Rules of Procedure and the General Terms and Conditions of the event and exhibition.
3. The fee for the use of the requested area and the requested services must be paid in accordance with the General Terms and Conditions, but no later than 21 May 2024 so that we can start the design or construction of the stand/requested area.
4. We are unable to provide the services requested during the exhibition.
5. Construction and furnishing requests made during the construction period of the exhibition (30 May 2024, 8:00 a.m. – 4 June 2024, 8:00 p.m.) will be fulfilled at a 100% surcharge.
6. The front lengths of the areas occupied in the outdoor area must be rounded to whole metres (min. 2 m). In the case of catering units, the space in front of the pavilions and buffet carts for guest service and consumption must be taken into account.
7. If a duly registered Exhibitor cancels his appearance after the registration deadline, the Organizers may fill his place, but he must pay the fee for the basic area. Orders can only be cancelled by registered mail with return receipt requested.
8. The exhibition area is handed over clean and is requested to be returned in this condition after closing.
9. The boundary walls of the stands must not be drilled or nailed, and any damage caused to the furnishings will be charged afterwards and indicated on the final invoice.
10. The decorations installed by the Exhibitor are requested to be removed during disassembly otherwise the cleaning costs will be invoiced to the defaulting Exhibitor.
11. The Main Organizer and the General Contractor do not assume responsibility for items placed in the exhibition area, at the Exhibitor's stand or left on the site. The parking lots are free of charge but they are not guarded, so take extra care of your valuables. Upon request, the Exhibitor may use the stand guard service by ordering it until the deadline.
12. The participants of the exhibition are obliged to comply with the general fire protection, occupational safety and electrical safety regulations as well as the rules of the exhibition! Otherwise, the Main Organizer, or the General Contractor or their agents are entitled to take action on behalf of the Main Organizer.

13. *The Exhibitor declares that he has valid official permits necessary for the activities he intends to carry out at the event.*
14. *By signing and returning this registration form, Exhibitor declares that he has read and expressly accepted the provisions contained in the Rules of Procedure and the General Terms and Conditions of the event and exhibition.*
15. *Neither the General Contractor nor the Main Organizer may be held liable for any damage caused by force majeure. Applicant acknowledges that, in accordance with the relevant chapter of the General Terms and Conditions, neither the General Contractor nor the Main Organizers may be held responsible for any damage caused in the event of unavoidable (force majeure) causes! Furthermore, Applicant expressly accepts that after the occurrence of unavoidable force majeure, there is no way or possibility to repay the consideration for, or costs of the fees and services already paid, therefore, the Main Organizers and the General Contractor may not be obligated, and are not obliged to repay the amounts paid so far. In accordance with the relevant chapter referred to above, "force majeure" shall mean events that occur in a manner not attributable to, beyond the control of, unavoidably by, the Parties (Exhibitor, General Contractor and Main Organizers of the exhibition) and which impede the contractual performance of the Parties or delay the performance of the contract, provided that such circumstances arose after the signature of the contract and were unforeseeable and unavoidable at that date.*
